**POWER CART OPERATORS**

The following rules and regulations govern the use of yearly power cart rentals. It is the responsibility of each member to abide by them. VIOLATORS MAY BE SUBJECT TO SUPENSION OF PRIVILEGES.

- 1) Drivers of power carts MUST be a minimum of 18 years of age.
- 2) Lessees are not allowed to transfer their lease.
- 3) All Lessees are required to complete a "Release of Liability" form.

**NOTE: SUSPENSION OF USE OF CARTS DUE TO WET CONDITIONS IS AT THE DISCRETION OF SUPERINTENDENT.**

**ETIQUETTE:**

- 1) Stay on paths wherever possible.
- 2) Adhere to signs and respect barriers and white lines around greens and traps.
- 3) Avoid all wet areas.

Power carts are hereby leased by the Club to the Lessee for the number of days of play as indicated above. Said property is not to be removed from the golf course and is to be returned promptly to the Lessor after use. Lessee represents that he/ she is familiar with the use and operation of said property. Lessee agrees to keep said property in Lessee's custody and not to sublease or re-rent the same.

Lessee agrees to keep said property in the same condition as when received. It is expressly understood and agreed that no right of action whatsoever shall accrue to the Lessee for damages of any kind whatsoever, whether to person and/or property; and/or loss of time, and/or loss or damage, arising from the use of, operation of, or in any way connected with the said property or any part thereof, from whatever cause arising. Lessee agrees to hold all parties free and harmless from all such damage.

Lessee expressly acknowledges personal liability to pay Lessor costs to repair all damage to said property and Lessor's costs including attorney fees incurred in collection of payments due from Lessee hereunder. The full agreement between the Lessor and Lessee is contained herein, and time is made of the essence of this agreement. The receipt of all above described property, in good order and repair is here by acknowledged by Lessee.

**NOT MORE THAN TWO PERSONS AND TWO GOLF BAGS SHALL BE IN THE CAR AT ANY ONE TIME.**

I hereby agree to pay for any damages that are sustained to the golf cart while in my possession and I am totally familiar with the operation of same. I have read and understand the rules and policies respecting the power cart operation on Connaught Golf Club and agree to abide by its terms and indicated above.
